2-2 Extension of period of stay

If you want to extend your period of stay continuing the same activities, you must carry out the procedures for extension of period of stay. Applications can be made prior to the expiry of your period of stay (from about 3 months prior to expiry for people whose period of stay is 6 months or more).

If the result of your application for an extension is not given within your allowed period of stay, it is possible to stay in the country for a maximum of 2 months after the expiry of your period of stay. (If the result of your application is given within the 2 months, the expiry is from the day of the result.)

The necessary documents required for applications vary depending on your status of residence and period of stay, so please enquire at the regional immigration bureau in the area where you live.
